I..ALTON NATIONAL CEMETERY.—The following-described tract of land, the "Soldiers Lot," located in the Alton City Cemetery, Alton, Illinois, is designated the Alton National Cemetery and placed under the jurisdiction of The Quartermaster General:

A tract of land NW $\frac{1}{4}$ NE $\frac{1}{4}$ sec. 13, T. 5 N., R. 10 W., third principal meridian, more particularly described as follows:

Beginning at a point which is 465.43 feet N., 16°28' E. and 2.95 feet S., 73°40' E. of the intersection of the north line of Fourth Street, now Fifth Street, with the east line of Plum Street which said intersection is also the southwest corner of block 32, of Hunter's Second Addition to Alton, Illinois, as the same appears of record in Alton Record N, pages 176, 177, 178; thence from said beginning point S. 73°40' E., 296.5 feet to an iron fence; thence S. 16°20' W., 70.5 feet to an iron fence; thence N. 73°40' W., 296.5 feet to an iron pipe; thence N. 16°20' E., 70.5 feet to an iron pipe and the place of beginning. Situated in the City of Alton, County of Madison, State of Illinois.

The tract of land described contains 0.48 acre.

III..MERITORIOUS UNIT COMMENDATION.—By direction of the Secretary of the Army, under the provisions of paragraph 14, AR 200-15, the Meritorious Unit Commendation is awarded to the following unit of the Army of the United States for exceptionally meritorious conduct in the performance of outstanding service during the period indicated. The citation reads as follows:

The 1388th Army Air Forces Base Unit, is commended for exceptionally meritorious conduct in the performance of outstanding service in Newfoundland, from April 1945 to February 1946. During this period, large numbers of aircraft were expeditiously serviced and many tons of mail and cargo processed. Throughout the height of redeployment, personnel of this unit provided excellent housing, messing, and transportation for air evacuees, passengers, and transient crews. The consistent high standards of efficiency, military discipline, appearance of personnel, installations, and equipment in the performance of duty brought great credit on the 1388th Army Air Forces Base Unit, the Air Corps, and the military forces of the United States.
