3. **Physical examination required for promotion.**—All officers listed above are required to take a physical examination in order to qualify for promotion (par. 9, AR 40-100). Reports of physical examinations prepared on Standard Form 88 (Report of Medical Examination) will be forwarded to The Surgeon General Department of the Army, ATTN: MEDDP, as soon as completed, and in any event in time to reach that office not later than 10 September 1951. The forwarding communication will state specifically that the report is furnished in connection with promotion in the Regular Army.
