**I. CAMP COOKE, CALIFORNIA.**—Effective 1 February 1953, Camp Cooke, California, a class I installation under the jurisdiction of the Commanding General, Sixth Army, is placed in an inactive status.

**II. MUSCLE SHOALS CHLORINE PLANT, MUSCLE SHOALS, ALABAMA.**—Effective 1 January 1953, the Muscle Shoals Chlorine Plant, Muscle Shoals, Alabama, is established as a class II industrial installation (contractor-operated) in active status under the jurisdiction of the Chief Chemical Officer.

**IV. TRANSPORTATION CORPS PROCUREMENT OFFICE, COLUMBUS GENERAL DEPOT, U. S. ARMY, OHIO.**—Effective 1 February 1953, the Transportation Corps Procurement Office, a class II activity under the jurisdiction of the Chief of Transportation, located at the Columbus General Depot, U. S. Army, Ohio, is discontinued, and the functions transferred to the Transportation Corps Supply Field Service Agency located at the Marietta Transportation Corps Depot, Marietta, Pennsylvania, a class II installation under the jurisdiction of Chief of Transportation.
