I..FINANCE OFFICES, U. S. ARMY, FORT SAM HOUSTON, TEXAS, AND LOS ANGELES, CALIFORNIA.—1. *Effective 1 January 1954*, the Finance Office, U. S. Army, Fort Sam Houston, Texas, a class II activity under the jurisdiction of the Chief of Finance is discontinued and its functions assigned to the Commanding General, Fourth Army.

2. *Effective 1 January 1954*, the Finance Office, U. S. Army, Los Angeles, California, a class II activity under the jurisdiction of the Chief of Finance is discontinued and its functions assigned to the Commanding General, Sixth Army.

3. The continuance of finance services now furnished to class II installations and activities by the Finance Offices, U. S. Army, Fort Sam Houston, Texas, and Los Angeles, California, shall be the responsibilities of the Commanding Generals of the Fourth Army and the Sixth Army, respectively, until other arrangements are authorized by the Department of the Army.

II..FORT HUACHUCA, ARIZONA.—*Effective 1 February 1954*, Fort Huachuca, Arizona, a class I inactive installation under the jurisdiction of the Commanding General, Sixth Army, is redesignated a class II installation under the jurisdiction of the Chief Signal Officer and placed in an active status.

III..ARMY ELECTRONIC PROVING GROUND, FORT HUACHUCA, ARIZONA.—*Effective 1 February 1954*, the Army Electronic Proving Ground is established as a class II activity, under the jurisdiction of the Chief Signal Officer, at Fort Huachuca, Arizona.

IV..SIGNAL CORPS ELECTRONICS RESEARCH UNIT, MOUNTAIN VIEW, CALIFORNIA.—*Effective 15 January 1954*, the Signal Corps Electronics Research Unit is established as a class II activity, under the jurisdiction of the Chief Signal Officer, at the Electronic Defense Laboratory, Mountain View, California.
