**I..QUARTERMASTER INTELLIGENCE AGENCY.**—Effective 1 March 1955, the Quartermaster Intelligence Agency is established at Washington, D. C., as a class II activity under the jurisdiction of The Quartermaster General.

**II..ARMY PHOTO INTERPRETATION CENTER.**—Effective 15 March 1955, the Army Photo Interpretation Center is established as an activity of the Army Intelligence Center. Section I, General Orders 65, 1954, is amended to include this activity.

**III..SUNNY POINT ARMY AMMUNITION LOADING TERMINAL, NORTH CAROLINA.**—Effective 1 April 1955, the Sunny Point Army Ammunition Loading Terminal, North Carolina, is established as a class II subinstallation of the New York Port of Embarkation, a class II installation under the jurisdiction of the Chief of Transportation.

**IV..ERIE ORDNANCE DEPOT.**—Effective 1 March 1955, the post office address of Erie Ordnance Depot, a class II installation under the jurisdiction of the Chief of Ordnance, is changed from Lacarne, Ohio, to Port Clinton, Ohio.

**V..NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE.**—Section III, General Orders 18, 1954, is amended as follows:
