II. YUMA TEST STATION, ARIZONA. Effective 3 August 1956, Yuma Test Station, Arizona, is announced as a permanent Department of the Army installation.

III. TRANSPORTATION FIELD MOVEMENT OFFICE, REDSTONE ARSENAL, ALABAMA. Effective 31 July 1956, the Transportation Field Movement Office, located at Redstone Arsenal, Alabama, is discontinued as an activity of the Second Transportation Zone, U. S. Army, Memphis, Tennessee, a class II activity under the jurisdiction of the Chief of Transportation.
