**I. GENERAL COURTS-MARTIAL.** The Commanding Officer U. S. Army Transportation Terminal Command (7278) is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22 (a) (6), to convene general courts-martial, effective 15 October 1957.

**III. ORDNANCE ASSEMBLY PLANT, MARYLAND.** Effective 1 October 1957, the Ordnance Assembly Plant, Maryland, a class II industrial activity under the jurisdiction of the Chief of Ordnance, located at the Army Chemical Center, Maryland, is placed in an inactive status.

**IV. RAVENNA ARSENAL, OHIO.** 1. Effective 1 October 1957, Ravenna Arsenal, Ohio, is redesignated from a class II industrial installation under the jurisdiction of the Chief of Ordnance, to a class II command installation under the jurisdiction of the Chief of Ordnance.

2. Effective 1 October 1957, the industrial activity located at Ravenna Arsenal, Ohio, is placed in an inactive status.

2. Effective 1 October 1957, the industrial activity located at Milan Arsenal, Tennessee, is placed in an inactive status.
