I..GENERAL COURT-MARTIAL JURISDICTION. Section I, DA General Orders 29, 1956, is amended to include the following:

The Commander in Chief, United States Army, Pacific, will supervise and take all action necessary regarding the administration of military justice including review of appeals from punishment imposed on Army personnel under the provisions of the Uniform Code of Military Justice, Article 15.

II..REDESIGNATION OF ARMED FORCES EXAMINING STATIONS.

1. The discontinuance of the Armed Forces Examining Station at Denver, Colorado, as an element of the U. S. Marine Corps Recruiting Station and designation as an element of the U. S. Army Recruiting Main Station effective 31 July 1955 is confirmed.

2. *Effective 1 November 1957*, the Armed Forces Examining Station at Ashland, Kentucky, is discontinued as an element of the U. S. Navy Recruiting Main Station and designated an element of the U. S. Army Recruiting Main Station.

III..OAKLAND STORAGE ACTIVITY, CALIFORNIA. *Effective 1 November 1957*, the Oakland Storage Activity, California, a class II depot activity of Sharpe General Depot, U. S. Army, California, under the jurisdiction of The Quartermaster General, is redesignated Oakland Depot Activity, California.

IV..ROCKY MOUNTAIN STORAGE ACTIVITY, COLORADO. *Effective 1 November 1957*, the Rocky Mountain Storage Activity, Colorado, a class II depot activity of Rocky Mountain Arsenal, Colorado, under the jurisdiction of the Chief Chemical Officer, is redesignated Rocky Mountain Depot Activity, Colorado.

V..TRACY STORAGE ACTIVITY, CALIFORNIA. *Effective 1 November 1957*, the Tracy Storage Activity, California, a class II depot activity of Sharpe General Depot, U. S. Army, California, under the jurisdiction of The Quartermaster General, is redesignated Tracy Depot Activity, California.

VI..VOORHEESVILLE STORAGE ACTIVITY, NEW YORK. *Effective 1 November 1957*, the Voorheesville Storage Activity, New York, a class II depot activity of Schenectady General Depot, U. S. Army, New York, under the jurisdiction of The Quartermaster General, is redesignated Voorheesville Depot Activity, New York.
