I. U. S. ARMY SIGNAL PROCUREMENT OFFICE, FORT GEORGE G. MEADE, MD. Effective 14 February 1958, the U. S. Army Signal Procurement Office is designated as a class II activity, under the jurisdiction of the Chief Signal Officer, at Fort George G. Meade, Md., a class I installation under the jurisdiction of the Commanding General, Second United States Army.
