I.. U. S. ARMY MILITARY MAIL TERMINAL, SAN FRANCISCO. Effective 15 October 1958, the U. S. Army Military Mail Terminal, San Francisco, a class II activity under the jurisdiction of The Adjutant General, is relocated from Fort Mason, California, to the Ferry Annex, Postal Concentration Center, Washington and Embarcadero Streets, San Francisco, Calif.

II..CAVEN POINT ARMY TERMINAL, NEW JERSEY. Effective 1 November 1958, the Caven Point Army Terminal, a class II subinstallation of the Brooklyn Army Terminal, a class II installation under the jurisdiction of the Chief of Transportation, is placed in an inactive status.

III..ABERDEEN ORDNANCE DEPOT, MARYLAND. Effective 30 September 1958, the Aberdeen Ordnance Depot is discontinued as a class II activity at Aberdeen Proving Ground, Maryland, a class II installation under the jurisdiction of the Chief of Ordnance.

IV..HIGH SCHOOL DEPARTMENT OF FREDERICK COLLEGE, PORTSMOUTH, VA. Effective at the beginning of the 1958-59 academic year, the High School Department of Frederick College, Portsmouth, Va., is authorized to participate in the military training program under the provisions of Title 10, United States Code, sections 8540b and 4051. This program will be known as the National Defense Cadet Corps Program.
