I. GENERAL COURTS-MARTIAL. The Commanding Officer, 1st Logistical Command (C), is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 1 November 1961.*

II. UNITED STATES ARMY ELEMENT, HEADQUARTERS, UNITED STATES STRIKE COMMAND (9792), MacDILL AIR FORCE BASE, FLORIDA. *Effective 18 October 1961,* the U.S. Army Element, Headquarters, U.S. Strike Command (9792), is organized with station MacDill Air Force Base, Tampa, Florida. Table of Distribution number 80-0792 is assigned to this activity.

III. NORTHWEST STARCOM FACILITIES. *Effective 15 August 1961,* the Northwest Relay Station, Seattle, Washington, and the Northwest Radio Receiving Station, Lynnwood, Washington, activities of the U.S. Army Communications Agency, a class II activity under the command of the Chief Signal Officer, are redesignated the Northwest Relay and Radio Receiving Station, Lynnwood, Washington.

IV. GEORGE WASHINGTON HIGH SCHOOL, ALEXANDRIA, VIRGINIA. *Effective 1 September 1961,* the NDCC unit at George Washington High School, Alexandria, Virginia, is withdrawn.

V. ORDNANCE ARCTIC TEST ACTIVITY, FORT WAINWRIGHT, ALASKA. Section I, Department of the Army General Orders 13, 19 April 1961, is amended to read as follows: *Effective 1 April 1961,* the Ordnance Arctic Test Activity is established as a class II activity, under the jurisdiction of the Chief of Ordnance, at Fort Wainwright, Alaska. The Ordnance Arctic Test Activity is attached to U.S. Army, Alaska, for logistical support and certain administrative support. With the concurrence of OG, USARAL, the Ordnance Arctic Test Activity is further attached to Yukon Command, USARAL, for logistical support and certain administrative support as mutually agreed to between representatives of the Chief of Ordnance and the Commanding General, Yukon Command.
