SUBJECT: Army Directive 2014-21 (Law Enforcement and Security Support at Arlington National Cemetery and the U.S. Soldiers' and Airmen's Home National Cemetery)

1. References:

- c. Memorandum, Secretary of the Army, 8 December 2011, subject: Law Enforcement, Security, Fire and Emergency Medical Services Support at Arlington National Cemetery and the U.S. Soldiers' and Airmen's Home National Cemetery (enclosure 1).
- d. Memorandum, Secretary of the Army, 8 May 2013, subject: Request for Exception to Recruit/Hire Civilian Personnel Arlington National Cemetery (UIC W1C9AA) (enclosure 2) (hereby rescinded).
- 2. Pursuant to the references, I am establishing an enhanced law enforcement, security and emergency services program for Arlington National Cemetery and the U.S. Soldiers' and Airmen's Home National Cemetery. The Secretary of the Army's statutory responsibilities and inherent authority to provide law enforcement, security, fire and emergency medical services to Arlington National Cemetery and the U.S. Soldiers' and Airmen's Home National Cemetery is delegated to the Commander, Joint Base Myer-Henderson Hall (JBMHH). Pursuant to this authority, the Commander shall provide and direct law enforcement, security, fire and emergency medical services for the two cemeteries on a reimbursable basis, as established by jointly executed installation support service agreements.
- 3. This requirement will be accomplished as follows:
- a. The Executive Director, Army National Military Cemeteries will enter into one or more installation support service agreements with the Commander, JBMHH, as required by paragraph 2.

- b. The Deputy Chief of Staff, G-3/5/7 will support the procurement and sustainment of operational and training requirements for law enforcement, security and emergency services at Arlington National Cemetery and the U.S. Soldiers' and Airmen's Home National Cemetery through the Total Force Management System.
- c. The Provost Marshal General will provide assistance and functional oversight to ensure the successful implementation of the provisions of this memorandum.
- d. Additionally, to maintain an appropriate level of security and force protection, the Executive Director, Army National Military Cemeteries will hire Department of the Army security guards in the GS-0085 series.
