**U.S. ARMY PRIORITY AIR TRANSPORT DETACHMENT AND ITS SUB-ELEMENTS,
THE PACIFIC AND EUROPEAN REGIONAL FLIGHT DETACHMENTS**

- 1.** Effective 1 September 2005, and subject to the exceptions set forth in this paragraph, and in paragraphs 3 and 4, below, the U.S. Army Priority Air Transport (USAPAT) Detachment (UIC: W31314), together with its sub-elements, the Pacific Flight Detachment (UIC: W31315) and the European Regional Flight Detachment (UIC: W31316), all presently assigned as elements or sub-elements of the U.S. Army Services and Operations Agency (USASOA) (UIC: SJW313AA), a field operating agency under the operational control of the Office of the Administrative Assistant to the Secretary of the Army, are realigned under the operational and administrative control of the Commanding General, Military District of Washington (CG, MDW) (UIC: W3J8AA). Excepting that the USASOA will continue to resource the operations of USAPAT and its referenced sub-elements, through and including 30 September 2005.
- 2.** Effective 1 October 2005, the USAPAT (UIC: W31314), together with its sub-elements, the Pacific Flight Detachment (UIC: W31315) and the European Regional Flight Detachment (UIC: W31316), including all missions, personnel, equipment, and resources are assigned to the CG, MDW (UIC: W3J8AA).
- 3.** The MDW will coordinate with USASOA in all situations affecting the ability of the USAPAT or its sub-elements to support Headquarters, Department of the Army and the commanders of major Army commands.
- 4.** Headquarters, USAPAT will remain at Andrews Air Force Base, Maryland. The Pacific Flight Detachment will remain at Hickam Army Air Field, Hawaii, under the operational control of the Commander, U.S. Army Pacific. The European Regional Flight Detachment will remain at Ramstein Air Force Base, Germany, under the operational control of the Commander, U.S. Army Europe.
