CITATION:

For meritorious service while performing off-base military law enforcement operations in the Naval District Washington from 1 August 1972 to 30 June 1973. Throughout this period, the Armed Forces Police Detachment, Washington, DC distinguished itself by consistently displaying an exceptionally high degree of professional competence, judgment, dedication, and cooperation in carrying out its mission in the Washington, DC area. Particularly noteworthy were the Detachment's initiative, vigorous planning and coordination in police matters pertaining to the 1973 Presidential Inaugural Parade, the funeral services of a former President and the Khartoum victims, Operation HOMECOMING and the visit of the Soviet Premier. On a routine daily basis, the Detachment patrolled the Naval District Washington Metropolitan area, rendering assistance to military personnel of all ranks and services, and apprehending those persons on unauthorized absence. The distinctive accomplishments of the Armed Forces Police Detachment reflected great credit upon the individual members of the Detachment and were in keeping with the highest traditions of the United States Armed Forces.
