6th INFANTRY DIVISION (LIGHT) AND UNITED STATES ARMY GARRISON, ALASKA—Reassigned	II

I—UNITED STATES ARMY WESTERN COMMAND. Effective 1 October 1989, the mission of Headquarters, United States Army Western Command is to serve as the Army component to Commander-in-Chief, United States Pacific Command (USCINCPAC) less the geographical areas of Korea and Japan, and for matters of USCINCPAC concern beyond the exclusive authority or transcending the geographical area of Commander, Eighth United States Army. The United States Army Western Command will command and support assigned and attached Active United States Army and United States Army Reserve units, installations, and activities in Alaska, Hawaii, and in possessions and trust territories administered by the United States in United States Pacific Command (USPACOM) and perform theaterwide functions for the Army in USPACOM as directed by the Department of the Army.

II—6TH INFANTRY DIVISION (LIGHT) AND UNITED STATES ARMY GARRISON, ALASKA. Effective 1 October 1989, the 6th Infantry Division (Light), with headquarters UIC: WDN6AA and United States Army Garrison, Alaska with headquarters UIC: W4UJAA and subordinate elements with the following UICs:

- a. Active forces: WASNAA, WBD5AA, WBEYAA, WBSZAA, WBYAAA, WBYBAA, WBY4AA, WB77AA, WCJ6AA, WCLDAA, WCY3AA, WC1PAA, WC17AA, WDGAAA, WDN699, WDN9AA, WDPBAA, WDPFAA, WDP-PAA, WDPQAA, WDPRAA, WDP3AA, WDQKAA, WDU8AA, WDYDAA, WD8XAA, WELYAA, WEPJAA, WEV8AA, WE2EAA, WGR8AA, WGOEAA, WG24AA, WG4ZAA, WAYBAA, WDUTAA, WHXMAA, WHO-VAA, WH1TAA, WH9QAA, WH9RAA, WH9SAA, W330AA, W4UHAA, WHPHA2 are reassigned to United States Army Western Command.
- b. Reserve forces: WRYDAA, W7UEAA are reassigned to United States Army Western Command.


